MSP WORKS CLOSELY WITH SURVIVORS TO REBUILD THEIR CREDIT, GAIN BUDGETING SKILLS, INCREASE INCOME, IDENTIFY SAFE UNITS, ACQUIRE LEASES IN THEIR OWN NAMES, AND FACILITATE PRODUCTIVE TENANT-LANDLORD RELATIONSHIPS.
