DURING FY 2022, MSP PURCHASED ANOTHER BUILDING THAT WILL BE IN OPERATION DURING FY 2023 AND WILL ALLOW MSP TO PROVIDE HOUSING TO MORE INDIVIDUALS IN NEED.

MSP WORKS TO REBUILD CLIENTS' CREDIT AND BUDGETING SKILLS, HELPS THEM SECURE EMPLOYMENT AND LEASES IN THEIR OWN NAMES, AND PROVIDES RENTAL SUBSIDY FOR 12 MONTHS (WITH THE OPTION TO EXTEND UP-TO AN ADDITIONAL 12 MONTHS).
